Oklahoma State University Bachelor of Science in Business Administration Degree Requirements

- A 2.00 Major GPA and a 2.0 Departmental GPA is required for graduation.
- A 2.00 minimum overall GPA is required for graduation.
- At least: 60 hours at a four-year institution; 30 hours completed at OSU; 15 of the final 30 and 50% of the upper-division hours in the major field completed at OSU. Limit of: one-half of major course requirements as transfer work; one-fourth of hours earned by correspondence; 8 transfer correspondence hours.
