All students who wish to major in Business should complete the following courses: ACCT 2003; ECON 2003; EEE 2023; MSIS 2103 or BADM 2233; and MKTG 3213 or MGMT 3013 and attain a minimum 2.70 overall GPA prior to undertaking upper-division courses. A minimum 2.50 GPA is required to graduate.

This plan is only one example of how a student may successfully complete degree requirements in four years. Students are responsible for completing the requirements as given in the official degree requirements sheet.

Note A: The student must indicate international cultural proficiency as evidenced by a combination of 9 hours of course credit in any of the following areas: (a) Modern foreign language; (b) Study abroad programs; (c) Semester study abroad program; (d) Upper division “I” designation course work.
